### **Supervisors Requests**

Mr. von der Osten stated mine is the same as last time, I think the landscape company is not taking care of the entrance the way they should. The mulch doesn't even cover the dirt and plants have Spanish moss hanging off of them like they are dead. It just doesn't look like a vibrant, active community when you pull in, it looks like an old non-maintained entrance. I know there are budget issues.

Mr. Oliver stated it serves everyone to have a good looking entrance and I would like to get with Brian and if it is simply a funding issue I think this is something we bring back to the developer and say we have to have additional funding for this.

Mr. Smith stated that has always been the issue, we would love to have 6" of mulch and annual flowers.

Mr. von der Osten stated I would be happy to support the CDD with a letter to the developer and ask that they fund that.

Mr. Smith stated he wasn't able to make it tonight but the operations chief at the sheriff's office that I have worked with the last couple of months I wanted to publicly thank the sheriff's office for getting engaged with our speeding issues and they have had a much bigger presence out here than for many years. Once we finally got over the hump of everybody understanding that the speed survey is probably not going to happen because of the funding issue but the sheriff's office has stepped up and said we should at the very least be in there enforcing the state mandated default speed limit of 30 mph in residential areas and they have been doing that quite a bit.

Richmond America finally put some piping and stuff out here to try to prevent people from going down the access road that shouldn't be going down the access road. I talked to one of our deputies that patrol and passed on to him what Keith Hadden had passed on to me and that is the second someone gets on that access road that is considered trespassing. That access road is for construction access and it is private property.

Freddie continues to do an amazing job, I appreciate the work, the time and effort he puts in. A lot of times that is a thankless job but he does a great job and a lot of people think that.

Mr. von der Osten stated I found out that in the last few weeks there has been a pretty large shakeup and turnover in management at Richmond America and they have been communicative

and cooperative. We were going through some issues that were brought up recently that they weren't aware of and they seem to be concerned and willing to work for a solution.

Mr. Smith stated that is good.

A resident stated the road that you were just talking about, the construction road, the map shows it is going to be a road.

Mr. Smith stated eventually that will be a Rolling Hills road, at some point that is supposed to be a four-lane road, a divided road and there will be another road with a median and it will run the length of the property and turn and tie into the beltway that will eventually run down the property line.

A resident stated then that is not the CDD or HOA, is that the state or county?

Mr. Oliver stated I will check with Keith Hadden to determine who owns that construction road. If the district doesn't own it we can't be involved in the trespass process.

Mr. Oca stated I received an email from a resident and he would like to have oak trees on Bradley Creek.
